Northwest Michigan Community Action Agency Earned Income Tax Credit Statewide Initiative

Dear Community Member,

There is a valuable service that can help you SAVE money and bring EXTRA money home. If you work, you might be eligible for the Earned Income Credit, or EIC. Households that qualify for the EIC could receive a refund of up to \$5,751

Do you qualify for the EIC for 2011?

- If you have *one child* and you earned less than \$36,052 (or \$41,132 for married workers), you might be eligible for a credit of **up to \$3,094**.
- If you have *two children* and you earned less than \$40,964 (or \$46,044 for married workers), you might be eligible for a credit of **up to \$5,112**.
- If you have *three children* and you earned less than \$43,998 (or \$49,078 for married workers), you might be eligible for a credit of **up to \$5,751**.
- Workers at least age 25 and under age 65 *without a qualifying child* who earned less than \$13,660 (or \$18,740 for married workers) might be eligible for a credit of **up to \$464**.
