- Countdown to destination for when they ask when we will be there.
- EHS Center-Based and HS Collaborative Centers-HS Collaborative Center is

included in the Direct Operated Child Outcomes. EHS Center Based-consistant from Fall to Winter-

- Head Start Collaborative School Readiness Social/Emotion, 10% drop and 11c slight drop. The staff were able to dig into this and found that one classroom had the drop due to having a different teacher in the fall and a new teacher doing it in the winter. Really can make a change in the number and interpretation. Other classrooms had the same teacher fall to winter.
- 360 view of the whole child.
- Working on strategies with the Collaborative Centers and attendance.
- Family Services-do the families know that these are available to them rather than just being in preschool or EHS.
 - Maybe they can hang something in the classroom.
 - Program flyers for NMCAA.
 - Mental Health talk during a classroom parent meeting-Family needs assessment is available to all the families, if it is marked yes i would like more information then the FES will follow up with the family. FES Bios are sent out in acceptance packets so that the families can connect with the family. Is there a way that the needs assessment can be more about this is about you and getting help and recognizing strengths before sending out the survey. Can the needs assessment be done in person?

 - Have this a topic for next month, to bring a snack list and ideas. Coaches have created an area on sharepoint for ideas with meal experiences.
